우리 학회는 2026년 11월 2일부터 4일까지 부산 BEXCO에서 제42차 정기학술대회를 개최합니다.

미국독성학회(SOT) Cynthia V. Rider 회장님과 일본독성학회(JSOT) Akihiko Hirose 회장님을 비롯하여 Cleveland Clinic의 김현중 교수님, 서울대학교 이장익 교수님 등 독성학과 규제과학 분야의 국내외 저명한 연구자들을 초청하여 수준 높은 학술강연을 준비하였습니다. 또한 비임상 안전성 평가, 규제과학, 국제 표준화, 질한모넬, 나노물질 위해성 평가, 정량 독성학 등 다양한 주제의 심포지엄을 통해 최신 연구성과를 공유하고, 산 · 학 · 연 · 관이 함께 독성학의 새로운 방향을 논의하는 자리가 될 것입니다.

독성학은 국민 건강과 환경을 보호하고 안전한 의약품과 화학물질의 개발을 뒷받침하는 핵심 학문입니다. 이번 학술대회가 독성학의 최신 지견을 나누고 분야 간 소통을 통해 새로운 연구의 가능성을 확장하는 자리가 되기를 바랍니다. 아울러 Young Scientist Forum, 학술상 시상식, 우수포스터 발표, 독성전문가 인증식, Travel Awards 등 다양한 프로그램을 통해 차세대 연구자를 격려하고 회원 간 교류와 소통을 더욱 활성화하고자 합니다.
